Abstract:

ITDAs as nodal Tribal Development Agency were set up during the 5th Five Year Plan Period. It began with the development of tribes through five year plans, bringing them to the mainstream of Indian society and culture. Most of the development programs failed to achieve the expected results. Further, after the 1990's, the process of globalization has in fact put the tribes of India in a rather difficult situation. Undoubtedly some among have become elites; but by and large the poverty situation has worsened among them. About the historical aspects relating to the emergence of Paderu ITDA, the Paderu division, multi-purpose block was inaugurated in 1956. It was converted into a tribal development block in 1962. The Integrated Tribal Development Agency (ITDA) Paderu, Vishakhapatnam District, is a society registered on 20 February, 1975 under the society's registration Act XXI of 1869 and started functioning from 4 December, 1975.

I. Introduction

Name of some of the Tribes in India are Nagas, Garos, Santhals, Has, Gonds, Todas, Andamanese, Nicobarese, Warlis, Thakurs, Baigas, Khonds, Mizos, Lepchas, Badagas, Sentinalese, Kotas etc. In simple language Tribes are those people who are close to nature and are mainly dependent on nature for their day to day needs. They are nomadic in nature and live in isolation. They mostly live in groups and interact with each other in their own language. They are very few in numbers and can easily be recognized by others. As they look and behave very differently when the village and the city people. In 1964 the first body of the panchayat samithi consisting of members from different village level bodies was selected. In 1975 an integrated tribal development project came into existence covering Paderu and some other tribal development blocks. In addition to these agencies many developmental institutions covering the fields of co-operative credit, educational services, medical facilities are established for the all round development of the tribals. Several protective legislations enacted by the state governments were applied to the agency area.

Objectives of the Study

- Integrated Tribal Development Agency (ITDA) in India and Andhra Pradesh.
- To attempt to Perception of Tribalson Paderu-ITDA-Government Programmes.

II. Methodology and Data Sources

Data collection included both primary and secondary data are used. The primary data was obtained through direct interaction with tribal's Peoples, Employees and student of Paderu ITDA and who involved the programmes of ITDA of Paderu in Visakhapatnam. The secondary data collected from Ministry of Tribal Affairs (MOTA) Annual reports, Welfare offices reports, journals, ITDA reports etc.

II.1. Sampling Method; The Convenient sampling method was used to select the beneficiary of ITDA and the questionnaire was framed on the awareness of tribal people about ITDA, jobs, payment of daily wages etc.

Sampling Units:

ITDA is an authorised and authoritarian institution that has to ensure tribal development. There are 8 ITDAs in the state of Andhra Pradesh. These are located in the following headquarter/districts Seethampeta ITDA/ Srikakulam, Parvathipuram ITDA/ Vizianagaram, Paderu ITDA/ Visakhapatnam, Rampachodavaram ITDA/ East Godavari, Kotaramachandrapuram ITDA/ West Godavari, Srisailem ITDA/ Kurnool, Guntur, Prakasam, Nellore ITDA/ Nellore, Chinthur ITDA/ East Godavari. From the 8 ITDAs the researcher selected Paderu ITDA and selected 50 respondents for the area of present study.

Sample Design:

The researcher represents 50 respondents have been selected for the present study; Out of 50 respondents 30 are Konda Dora, 10 are Kondh Valmiki and remaining of 10 respondents are Porja communities. They are from Paderu ITDA of Visakhapatnam-Andhra Pradesh and 5 villages were selected for respondents Survey. These villages are located at the distance of 20 to 30 Kms from the Paderu ITDA of Visakhapatnam.

Statistical Tools: The respondents use statistical tool to analyze interpreted the data such as percentage analysis Weightage Average Analysis (WAA), graph and diagrams for this study.

Field work and experience: The researcher stayed minimum in ITDA of Paderu in Visakhapatnam. The collected data for this study through tribals, employees and students. This experience the researcher learned many characteristics of tribe life, their languages, Communications with tribes and observed their life styles. They have their own languages in all aspects of life.

III. Integrated Tribal Development Agency (ITDA) in India

In India total ITDAs was 193 with its included 2 Union Territory. The Modified Area Development Approach (MADA) Pockets was 259 in India and the Cluster and States having Scheduled Area and Tribes Advisory Council (TAC) are 82, As many as 118 Blocks of Odisha having 50% or more ST population have been covered by 22 ITDAs in the state viz Each ITDA has a Project Administrator, who is senior Class-I Officer of OAS/IAS cadre. Besides, every ITDA is facilitated with an Engineering Cell with an Assistant Engineer, as the Technical head. In the above table observe the state of Madhya Pradesh have 31 ITDAs in India and the lowest ITDAs is the state of Uttar Pradesh. Some of State having only TACs. Hence, some are states having Scheduled Areas and Tribes Advisory Councils (TACs) only.

III.1. Modified Area Development Agency (MADA) SCA to TSP

The Special Central Assistance (SCA) is provided by the Ministry of Tribal Affairs (MOTA) to the State Government as an additive to the State Tribal Sub-Plan (TSP), where state plan provisions are normally forthcoming to bring about a rapid economic development of tribal's. From Tenth Five year Plan period, the objective and scope of SCA to TSP, which was originally meant for filling up of the critical gaps in the family based income generation activities of the TSP, has been expanded to cover the employment-cum-income generation activities and the infrastructure incidental thereto not only family based, but also run by the Self Help Groups (SHGs)/Community. Ministry of Tribal Affairs, Government of India, releases Special Central Assistance in the shape of grants-in-aid to the State Government keeping in view the tribal population percentage of the state.

III.2. Cluster Pockets Approach

The cluster approach has been introduced from the middle of the 7th Five Year Plan Period in order to bring smaller areas of tribal concentration beyond the MADA pockets into the Mainstream of development. Contiguous areas having a population of 5,000 or more with at least 50% tribal concentration are identified as clusters. 14 such clusters have been identified covering Parts of 13 Blocks in 10 districts of the State covering 62,021 ST populations (2001 census). The Administrative arrangement for these 14 clusters is similar to that of MADA pockets. For development of tribals in Clusters, in addition to normal programmes, SCA is provided for implementation of IGS in group mode and community benefit-oriented programmes.

III.4. Dispersed Tribal Development Project (DTDP)

As an extension of TSP strategy, the dispersed ST population of the state located outside the ITDA/ MADA/ Cluster Pocket/ Micro Project areas, is covered under a special project for tribal development called, 'Dispersed Tribal Development Project (DTDP)', Odisha Scheduled Castes and Scheduled Tribes Development Finance Cooperative Corporation Limited is the nodal agency that operates DTDP for the total development of dispersed STs. Tribal Development involves upliftment of a number of Tribal Groups, which are at different stages of socioeconomic development. Dispersed tribals comprise a substantial part of the total tribal population in the State. The proportion of dispersed tribals, however, varies considerably from one region to another and also between different areas in the same region. Dispersed Tribal population constitutes about 27% of the total tribal population in the State. The following activities are being implemented for which assistance is being provided to the Dispersed Tribal Population living below the Poverty Line: Provision of subsidy under various bankable Income Generating Schemes. Community Minor Irrigation Projects such as LIP, WHS, Check Dam etc. Training Programme for self-employment, wage employment etc. Bankable income generating schemes consist of schemes in the areas of Agriculture/Horticulture Development, Minor Irrigation Animal Husbandry Fishery Small and Village Industry Vocational Trade and Small Business Emphasis has been given to organize training programme under self-employment and skill up-gradation Development as a result of which 1160 candidates have so far been benefited.

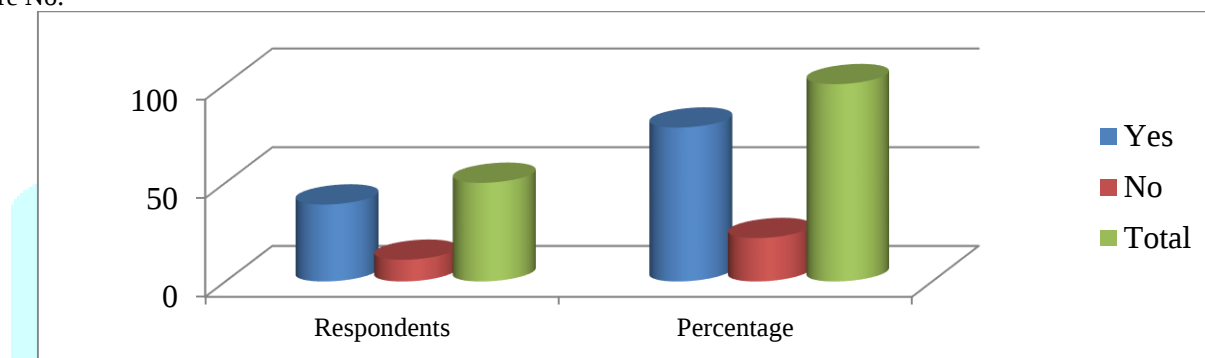
IV.ITDAs District wise interpretation in Andhra Pradesh

- ✓ ITDAs District wise in Andhrapradesh Covered are Seethampeta/Srikakulam, Parvathipuram/ Vizianagaram, Paderu/ Visakhapatnam, Rampachodavaram/East Godavari and Kotaramachandrapuram/ West Godavari.
- ✓ The 5 ITDAs covered district wise 42086.00 insq.Kms.
- ✓ In the 5 ITDAs covered total mandals are 59 and 4,737 ST villages.
- ✓ In the 5 ITDAs covered total mandals are 59 with 553 Non- ST villages.
- ✓ The total population of all ITDAS are 12, 25,675 out of those population ST population have 9, 60,245.
- ✓ The Lowest population of ST is 74,280 in Seethampeta/Srikakulam.
- ✓ In total ST population included Male are 4, 96,325 and Female are 4, 83,920.

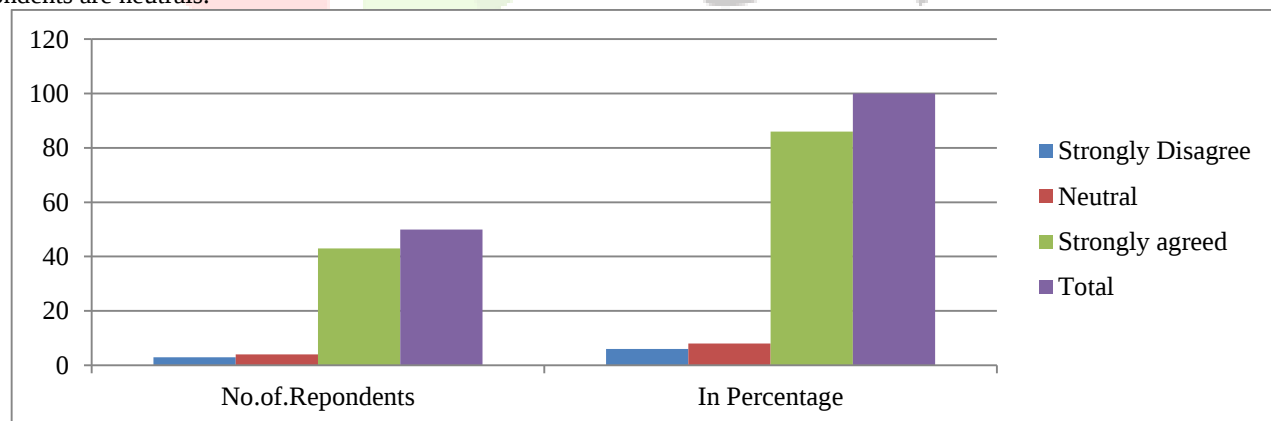

**V.2.Payment of wages in cash**

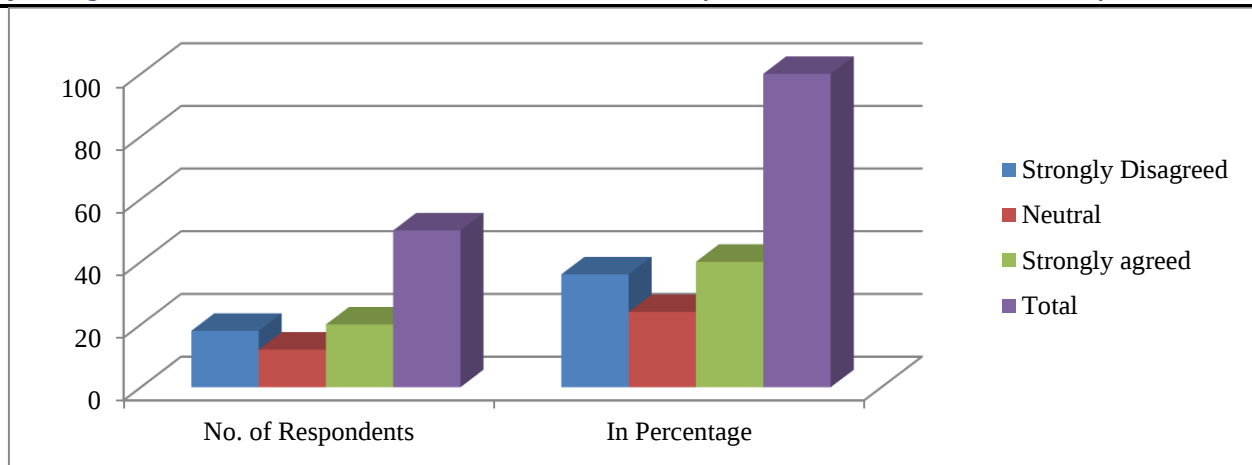

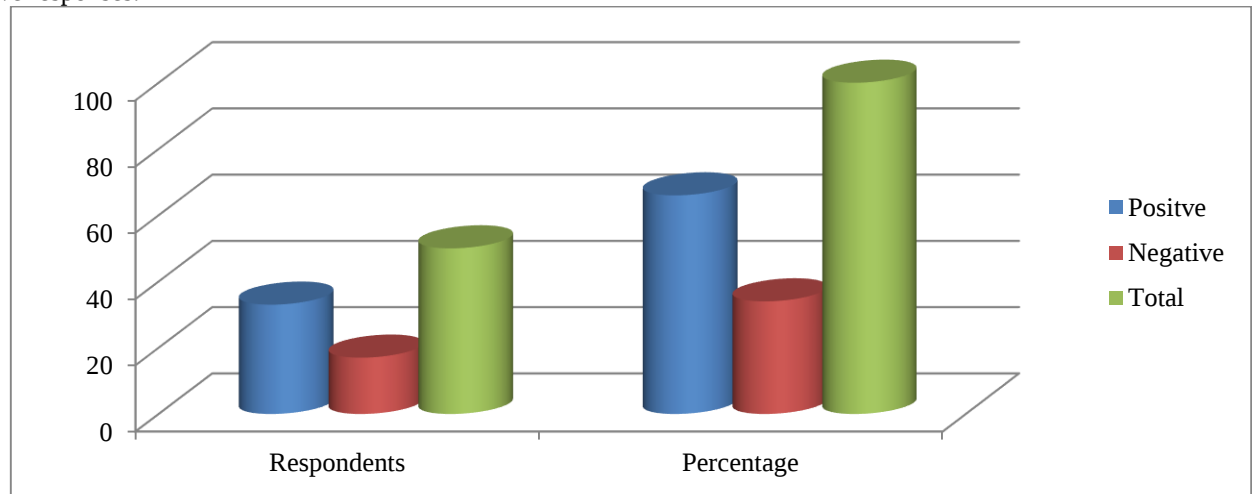

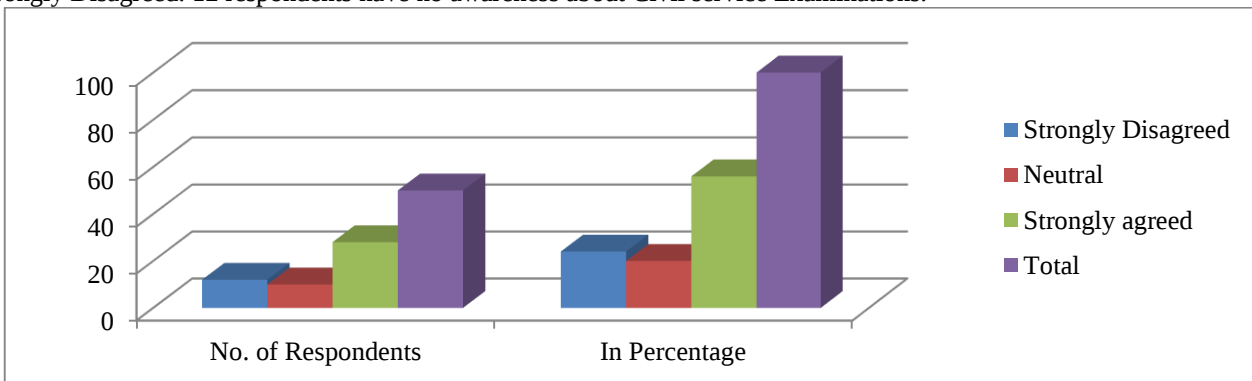
The primary survey on Tribal's Nodal Agency majority of the respondents i.e 66% members have positive responses and 34% have negative responses.

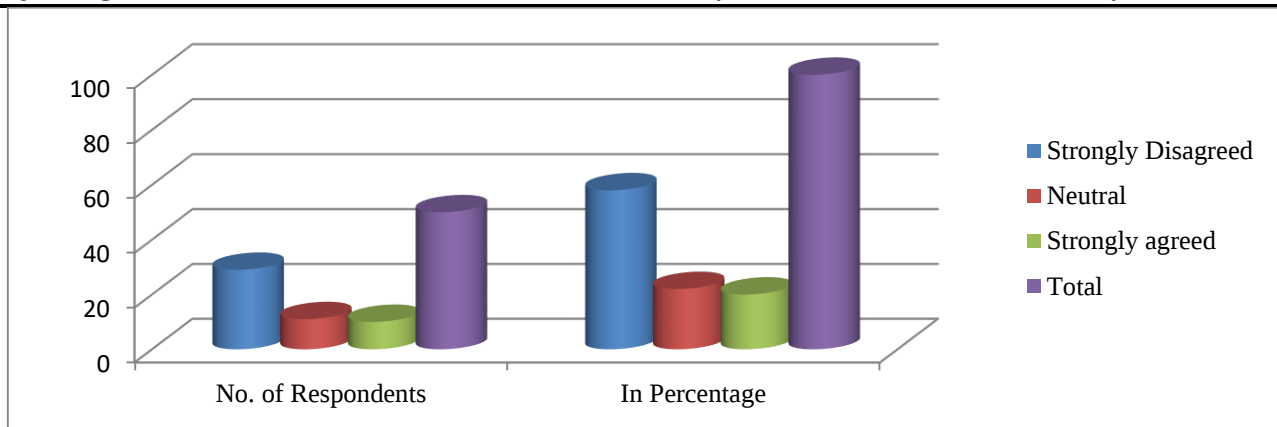

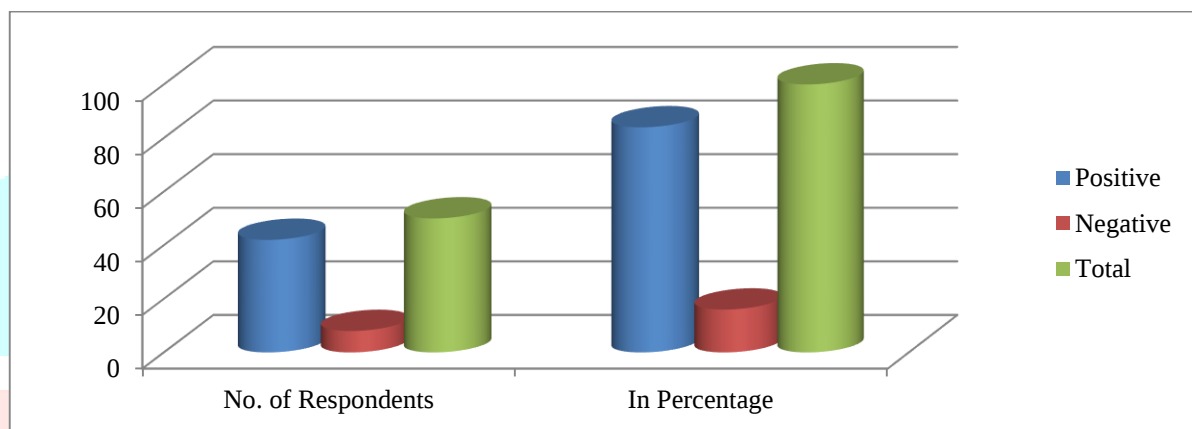

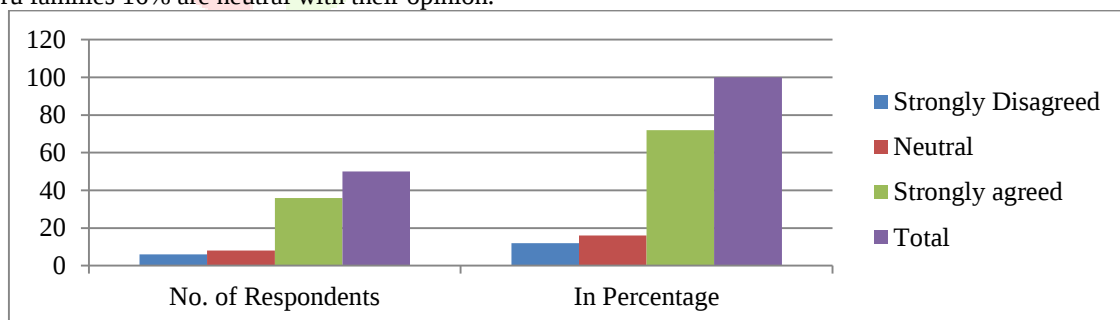
