The Vishram society consists of many old people and surprisingly young people too.

On the other hand, Vikas Swarup's first novel 'Q & A' deals with major themes as Slums, Poverty, and Exploitation', whereas Love, Friendship and fate are the other themes those are woven in the narrative. He is optimistic and believes in no religion but continues to help others and do good which paved his destiny turn upside down and luck heralded him.

In Six Suspects, Swarup returns with an equally high-concept tale that uses a murder investigation to launch a riotous tour of contemporary India. Here, Swarup shows that how major characters find individual dilemma and change their survival strategies through situation to situation as Vivek (Vicky) Rai a notorious son of Jagannath Rai, Home Minister of Uttar Pradesh. The Delhi police identify six suspects: corrupt womanizer Mohan Kumar; Shabnam Saxena, a sizzling actress; Hollywood adult-film producer Rick Myers; cell-phone thief Munna Mobile; Eketi Onge, member of a vanishing tribe from an island in the Bay of Bengal; and Jagannath Rai himself.
